### Web based data entry

Dr. Conrad, the Registry Chairman, is in the final stages of developing our web based data entry system which is currently being beta tested right now. Once the system is finalized we will not be able to accept registry forms either mailed in or in electronic format. Centers will be required to use the web based data entry system. ELSO will send out notices giving you time to submit any forms that have not been sent in. Advantages of web based data entry will be that equipment fields will always be up to date, date fields can be displayed in your international standard and that centers will be able to get patient lists, reports, simple queries any time they wish! We are expecting this to happen early 2009. You

will then be contacted on how to receive your user names and passwords.

### **INO Registry**

The pilot period of the INO registry will be ending at the end of 2008. What this means is that it will now be open to all of our centers and the majority of bumps have been worked out. We have some excellent feedback and will be making some minor changes to the data we collect. ELSO would like to encourage your center to participate in this important endeavor.
