topics to be addressed include device development, new paradigms in ECMO management, and long-term follow-up and outcomes after ECMO. There will also be a joint session on transitioning from ECMO to other forms of support with the International Society for Heart and Lung Transplantation, plus a celebration of 50+ years of ECMO with some of the original pioneers discussing how and why they did it. In recent years, clinicians and researchers have devoted an enormous amount of attention to Extracorporeal Cardiopulmonary Resuscitation (ECPR). Rightly or wrongly, I have always believed that ECPR is the icing on the cake of an ECMO program, something to be tackled only once high-quality ECMO is a daily part of clinicians' working lives. ECPR is not easy to do well. If for in-hospital cardiac arrest, should it only be performed for witnessed arrests in monitored locations? If for out-of-hospital cardiac arrest, should cannulation occur in the Emergency Department or on the sidewalk where the patient arrested? Can we extend these principles to young children or the elderly? What other ICU management strategies should we bundle with it? How can the requisite infrastructure be established? And how robust is the data supporting all this anyway?

The Opening Plenary of the 34th Annual Conference will tackle these questions head-on. There will be a fascinating case study of considerable complexity involving ECPR, Wilderness Medicine, and the US Military, plus lectures and a panel discussion from some of the world's foremost experts on the topic. For anyone with a specific interest in ECPR or in wider applications of ECMO in general, this session is a must.

# **Case Study**

A 70 year old man with end-stage lung disease due to COPD developed bronchitis. His  $PaCO_2$  is 70, bicarbonate 45, pH 7.35,  $PO_2$  80, respiratory rate 45. Confused, getting exhausted. This is a typical and stage lung disease exacerbation. He is admitted to your ICU. Noninvasive ventilation assistance does not help. He is getting worse. Someone suggests ECCO<sub>2</sub>R but you do not have an ECCO<sub>2</sub>R machine. What do you do?

 $ECCO_2R$  is extracorporeal CO<sub>2</sub> removal. It is one component of ECMO. You could put this patient on VVECMO at low flow and high sweep gas which will remove CO<sub>2</sub> selectively. If you don't want to use full ECMO cannulation and flow you can use a neonatal ECMO circuit with neonatal double lumen cannula and a flow rate around 400-500 ml per minute. A small membrane lung and pump combination specifically for CO<sub>2</sub> removal called Hemolung is recently on the market. It is similar to a neonatal ECMO circuit and is intended to be used at flow 400-500 ml/min.

Bring the PaCO<sub>2</sub> down at 10 mm/hour to avoid intracranial bleeding due to rapid pH shift. In a few hours the patient is alert and awake and very comfortable with respiratory rate of 10. The patient states that he has not felt normal for a year. You should treat bronchitis with the hope that he will return to baseline but, this is a short-term symptomatic solution (unless he is listed for transplant). When ECCO<sub>2</sub>R is weaned or discontinued the patient will return to hypercarbia, renal compensation, and dyspnea. Research in this area is aimed at palliative care with a small wearable membrane lung with automatic sweep gas control for long-term CO<sub>2</sub> removal.


# **ECMO EQUIPMENT UPDATES**

Our community and key stakeholders have been working hard on access to equipment, and innovation at the bedside. We continue to check in with device developers and regulatory agencies. Heading into the Fall of 2023, we understand that equipment issues continue to be an increasing concern for many.

We would like to develop a more quantitative survey to better portray access to ECMO constraints that centers may be experiencing in a manner where those that can act have the information they need available. Please let us know if you would like to be involved in the survey design – as an ECMO practitioner, device developer, or regulatory agency. We are interested in an inclusive approach for this second survey.
